TERMS & CONDITIONS

A. CANCELLING AND RESCHEDULING WORKSHOPS:

1. **Cancellation or Rescheduling by OPTIMAL:** OPTIMAL reserves the right to cancel or reschedule workshops due to insufficient participant numbers or unforeseen circumstances. If OPTIMAL exercises this option, participants or the sponsoring organization will be notified at least two (2) calendar weeks prior to the scheduled workshop date. OPTIMAL will not be liable for any expenses incurred by participants or sponsoring organizations because of such changes.
2. **Right to Adjust Workshop Details:** OPTIMAL reserves the right to:
 - a) Adjust workshop pricing, schedule, and agenda
 - b) Replace workshop facilitator(s)

B. APPLICATIONS AND TRAINING GUIDELINES:

1. **Issuance of Certificate:** Participants who have completed all certification requirements stipulated by Hogan Assessments Inc. and settled all workshop and related fees due to OPTIMAL will be issued a certificate and will henceforth be recognized as a certified individual.
2. **Certified Party:** Certification is granted to the individual and does not belong to the sponsoring organisation.
3. **Rights of Certified Individuals:** Certified individuals may purchase Hogan Assessments reports and materials; however, they are not authorised to certify others.

C. CONFIRMATION AND PAYMENT:

1. **Invoicing and Payment:** Total workshop fees will be invoiced upon registration, and payment must be remitted in accordance with the terms stated in the invoice.
2. **Invoice Currency and Applicable Taxes:** Unless otherwise agreed by OPTIMAL, the invoice currency will be based on the local currency and applicable taxes of the client's business entity location or domicile address, provided that the entity is situated in a jurisdiction where OPTIMAL has a registered legal entity. If the client's business entity or domicile address is outside such jurisdictions, invoicing will be determined by mutual agreement and confirmed in writing via email.

D. SPECIAL DISCOUNTS AND OFFERS:

1. **Eligibility for Bundle Pricing:** Participants are eligible for bundle pricing when registering for either of the following combinations:
 - a) Hogan Certification Workshop + Advanced Interpretation Certification Workshop, or
 - b) Hogan Certification Workshop + Advanced Feedback Certification Workshop.

To qualify, both workshops must be held at the same location, take place within the same calendar year, and be invoiced together.
2. **Impact of Deferral:** If a participant defers the Advanced Certification Workshop to a different calendar year than the Hogan Certification Workshop, the bundle pricing (including any applicable group bundle discount) will no longer apply. Please refer to Section E: Special Arrangements for the relevant terms and conditions.
3. **Group Discount:** A group discount is available when two or more participants from the same organisation register for the same workshop session and are billed under the same invoice within the same calendar year.
4. **Application of Discounts:** Bundle Pricing and Group Discounts cannot be combined with each other or with any other promotions, coupons, or special offers.

E. SPECIAL ARRANGEMENTS:

1. **Replacement of Participant:** Participants who are unable to attend the workshop and have not completed the pre-workshop online assessments or 1-on-1 debrief and replacement options may nominate another participant from the same organisation as a replacement without penalty. Advance notice of at least two (2) calendar weeks prior to the registered workshop date is required for such changes. Any additional expenses incurred by Optimal due to late notice will be charged to the participant or their organisation.
2. **Deferral Within the Same Calendar Year:** Participants may defer their attendance to another workshop held at any location within the same calendar year of the registered workshop without penalty or additional charges, provided that advanced notice of at least two (2) calendar weeks prior to the registered workshop is given. Any additional expenses incurred by Optimal due to late notice will be charged to the participant or their organisation.
3. **Deferral Beyond the Same Calendar Year:** If a participant defers attendance to a workshop held beyond the same calendar year of the registered workshop, they will be required to pay any differences in workshop pricing, venue fees, or applicable taxes.
4. **Limit on Deferral Requests:** A request to defer without penalty may only be made once per participant within the same calendar year of the initial registration. Any additional expenses incurred by Optimal due to this deferral request will be charged to the participant or their organisation.

5. **Change of Language Session:** Participants who have registered and paid for the Putonghua session may opt to change to an English session held at any location within the same calendar year of the registered workshop, subject to agreement from OPTIMAL. A request to change without penalty may only be made once per participant. Any additional expenses incurred by Optimal due to this change request will be charged to the participant or their organisation.

6. **Approval of Special Arrangements:** All requests for special arrangements as stipulated above are subject to approval by OPTIMAL.

F. CANCELLATION POLICY:

1. **Non-Refundable Fees After Pre-Workshop Completion:** Once the pre-workshop online assessments or 1-on-1 Debrief and Replacement Options have been completed, the full workshop fee becomes non-refundable and non-transferable. The full fee must be paid.
2. **Refund Eligibility Before Pre-Workshop Completion:** If the pre-workshop online assessments or 1-on-1 Debrief and Replacement Options have not been completed, refund eligibility will be based on the following written notice periods:
 - c) Cancellations received at least two (2) weeks prior to the workshop start date are eligible for a refund, minus a 10% administration fee.
 - d) Cancellations received at least one (1) week prior but less than two (2) weeks prior are eligible for a 50% refund.
 - e) No refunds will be granted for cancellations submitted less than one (1) week before the workshop start date.

G. 1-ON-1 DEBRIEF AND REPLACEMENT OPTIONS:

1. **Validity of 1-on-1 Debrief and Replacement Options:** If the 1-on-1 debrief or replacement options are not completed within three (3) calendar months following the scheduled workshop date, all such entitlements will be deemed null and void, with no obligation to provide them in the future.
2. **Cancellation or Rescheduling Notice:** Advance notice of at least forty-eight (48) hours is required to cancel or reschedule any 1-on-1 debrief or replacement options involving the presence of Optimal's consultants. A penalty fee of USD 200 or its equivalent in the invoicing currency will be charged for insufficient notice or failure to provide notice.
3. **Late Attendance or No-Show:** Late attendance of more than ten (10) minutes, or failure to attend, will constitute a cancellation of the 1-on-1 debrief or replacement options involving the presence of Optimal's consultants.

H. DATA PRIVACY & CONFIDENTIALITY

1. **Compliance with Data Protection Laws:** All parties shall comply with all applicable data protection and privacy laws in the jurisdictions where the workshop is conducted, or the laws of Singapore for virtual workshops. Optimal shall process participant personal data for purposes related to the organisation, delivery, and improvement of the workshop and certification process, as well as for other purposes disclosed to participants, including the sending of updates, programme offerings, and newsletters by Optimal (with the option to unsubscribe at any time). Optimal shall implement appropriate technical and organisational measures designed to protect such data from unauthorised access, disclosure, or loss.
2. **Sharing of Data with Hogan Assessments Inc.:** For the purpose of completing the certification requirements, participants acknowledge that certain personal information must be shared with Hogan Assessments Inc., the assessment provider responsible for administering and issuing the relevant certification. Optimal will take reasonable steps to ensure that Hogan Assessments Inc. maintains appropriate data protection and security standards; however, participants understand that Hogan Assessments Inc. operates as an independent data recipient with its own systems, policies, and controls. As such, Optimal cannot guarantee the security of information processed, stored, or transmitted by Hogan Assessments Inc. or any other third-party service provider engaged for workshop delivery.
3. **Confidentiality of Proprietary Information:** Both parties agree to maintain the confidentiality of all proprietary information, materials, and content shared during the workshop. Such information shall not be disclosed to any third party without prior written consent, except where disclosure is required by law.
4. **Survival of Obligations:** These confidentiality obligations shall survive the completion or termination of this Agreement.
